Road Works Speed Limit Order, No.1 of 2018 on the N11 In the townlands of Ferrycarrig, Killeen, Saunderscourt, Kitestown, Newcastle, Newcastle Lower, Kereight (ED Kilpatrick), Kyle Upper

Notice is hereby given that Wexford County Council, in exercise of the powers under Section 10 of the Road Traffic Act, 2004, in the interests of road safety and to facilitate the construction of the N11 Killeen to Newtown Pavement Improvement Works Phase 1; has made an Order entitled Road Works Speed Limit Order No.1 of 2018 relating to the N11 in the townlands of Ferrycarrig, Killeen, Saunderscourt, Kitestown, Newcastle, Newcastle Lower, Kereight (ED Kilpatrick), Kyle Upper to apply a road works speed limit of

Notice is hereby given that Wexford County Council, in exercise of the powers under Section 10 of the Road Traffic Act, 2004, in the interests of road safety and to facilitate the construction of the N11 Killeen to Newtown Pavement Improvement Works Phase 2; has made an Order entitled Road Works Speed Limit Order No.2 of 2018 relating to the N11 in the townland of Newtown to apply a road works speed limit of
