At the outset, Mr. M. Drea informed the meeting that there were technical issues which meant those coming in remotely could hear what was being said in the Chamber but those in the Chamber couldn't hear the remote attendees. Mr. Drea apologised for the inconvenience caused.

Mr. T. Enright briefed the Members on an announcement last Friday of funding for Waterford airport. Mr. Enright confirmed a combination of public and private investment with Wexford County Council due to make a modest investment of c€400,000. This update was broadly welcomed by the Members.

1. Opening address – Mr. Tom Enright, Chief Executive

Mr. T. Enright advised that the 2024 budget reflects a 9% increase on 2023. Mr. Enright said the increase reflects the increased cost of doing business and increase in service provision. Mr. Enright advised that the budget will provide for high quality services in 2024.

3. Draft Budget 2024

Consideration of Statutory Budget Tables

Ms. L. Lacey then brought the Members through each line of the budget tables and together with her colleagues from the Management Team responded to queries from the Members on a number of elements of the Draft Budget, as follows:

Division A

Clarification on increase in outturn for 2023 for A0904, A0905 and A0999.

- Query as to what the loan charge in A0602 is?
- Query as to why mobility aid grants were underspent in 2023?
- How much of spend is based on proposed rent increases in 2024?
- What is RAS expenditure of €3.6m spent on?
- Request for additional breakdown of dereliction funding.
- Request that a second Vacant Homes Officer be employed.
- Query in relation to the funding for homelessness.

Cllr. Jackser Owens left the meeting at this point.

- Query as to how the Council can address falling income.
- Query if Wexford County Council is funding RTB inspections or if the cost is recoupable.

Division B

- How can roads funding be increased?
- Is Wexford County Council installing new public lighting from its own resources and if so, is it funded from B0501?
- Is Wexford County Council reducing its own funding in 2024 under B0406?
- Why are there reductions in B0305 and B0406?
- Should Wexford County Council seek to increase income by increasing parking charges?
- Can the funding of B0305 be kept at 2023 level with an increase in income?
- > Need for additional investment in roads to enhance tourism offering.

Cllr. L. Kelly left the Chamber at this point.

Division C

- ➢ Is grant for septic tanks included in division C?
- How are water services costing the Council €2m if it is a function of Uisce Éireann?
- If Uisce Éireann are no longer going to cover the CMC, is there any service we can pull back on?

- What feedback is obtained on festivals which are funded by the Council?
- What is the total funding for the Opera Festival?
- > Why is Wexford Borough MD the only MD with a specific Culture Night budget?

Division G

- Request for clarification what G0101 consists of?
- Is there a significant problem with horse control as G0405 is a significant cost?
- > Where does funding for school meal programme come from?

Division H

- Will there be a reduction in the cost of producing the register of electors due to changes?
- ➤ Is the % of irrecoverable rates increasing?
- Query in relation to the service support costs for motor tax.
- Request for breakdown of motor tax income or value of motor tax income.

Cllr. C. Byrne proposed an amendment to increase the Amenity Grant by €1,000 per Councillor with a commensurate reduction in other areas of F0401. This was seconded by Cllr. M. Sheehan and agreed by all.

Decision on Rates to be applied to Vacant Premises

Recommendation to retain tiered basis.

- Retain 90% relief for all properties with annual rates to €2,000
- Apply 80% relief for properties with annual rates over €2,000 and less than €10,000
- Apply 60% relief for properties with annual rates over €10,000

Cllr. T. Forde proposed a reduction of 10% on each of the three tiers of the Rates Abatement Scheme (new rates to be 50%, 70% & 80%). This was seconded by Cllr. F. Ó'Súilleabháin.

The Cathaoirleach advised that there would be a roll call vote in relation to Cllr. Forde's proposed amendment to the Rates Abatement Scheme. The outcome was that the proposal to amend the Rates Abatement Scheme was defeated with 8 in favour and 20 against. The voting was as follows:

On foot of the adoption of the proposed tiered rates abatement, Wexford County Council makes a scheme for the abatement of rates due to it by liable persons, or classes of liable persons, in respect of vacant properties in accordance with the provisions of Section 9 of the Local Government Rates and Other Matters Act 2019, as amended. Such a scheme in respect of vacant property will provide for an abatement of either 60%, 80% or 90% (depending on value of annual rates) of rates due to Wexford County Council by a liable person for the financial year ending 31 December 2024.

Adoption of Annual Rate on Valuation (ARV)

Recommendation – Retain ARV of €0.253

On the proposal of ClIr. B.A. Murphy, seconded by ClIr. G. Carthy and agreed by all, the Members resolved to retain the ARV of ≤ 0.253 .

Decision on Small Business Support Scheme

Recommendation - retain existing scheme

- ➤ To provide SBSG at 10% of Annual Rates up to a max of €800
- > To be applied to all with annual rates up to €30,000 meeting T&C's

On the proposal of Cllr. G. Carthy, seconded by Cllr. M. Whelan and agreed by all, the Members resolved to retain the existing Small Business Support Scheme.

Adopt 2024 Budget with or without amendment

On the proposal of ClIr. B.A. Murphy, seconded by ClIr. O. Walsh and agreed by all, the Members resolved to adopt the 2024 budget with an amendment to increase the Amenity Grants by $\leq 1,000$ per Member ($\leq 7,000$ to $\leq 8,000$).

Mr. T. Enright thanked Ms. L. Lacey, Mr. S. Begley, Ms. A.M. Colfer, Mr. D. Noonan and the Directors of Service for their efforts in drafting the budget.
