Introduction

This is the second progress report of the Wexford County Council Local Authority Climate Action Plan 2024-2029. The plan was adopted by the elected members in February 2024 and published in March 2024. This progress report reflects the plan implementation period from adoption in February 2024 to December 2025 and aligns to the Government's National Climate Objective (to achieve the transition to a climate resilient, biodiversity rich, environmentally sustainable and climate neutral economy by 2050).

Full Accountability

The core targets of Wexford County Council's Climate Action Plan are a 51% absolute reduction in the Council's greenhouse gas emissions by 2030 and 50% improvement in the Council's energy efficiency by 2030

In addition, the plan includes a range of climate adaptation actions, aimed at improving the resilience of the County to the impacts of climate change as well as a range of mitigation actions, to reduce future impact on the climate.

Influencing, Advocating and Facilitating other Sectors

While the Climate Action Plan specifically sets out Wexford County Council's full accountability for reducing greenhouse gas emissions across its own assets, the Council is also committed to influencing, advocating and facilitating other sectors, to meet their own climate targets and ambitions. Wexford County Council engaged with a number of sectors, organisations and groups since the plan was adopted in February 2024. The Climate Action team initiated/engaged/attended numerous public awareness events to emphasise the Climate Action message to the citizens of Wexford. These sectors and stakeholders included Agriculture, Sustainable Energy Communities (SEC), Business Sector, Community & Voluntary groups, PPN, Educational and Third Level Institutions.

Climate Action Reporting

The following outlines the Climate Action reporting completed by the Climate Action Team as set out below.

National Climate Action Plan

The Council will, in accordance with Part 3(w) of the Local Authority Climate Action Charter, continue to report annually to the DCC on progress on climate action at local level as part of the delivery of the national climate objective.

Sectoral Performance

The Council continues to report annually on their performance on climate action by way of KPIs to inform the performance of the local government sector on climate action, as part of the local government DECA 2030 Strategy.

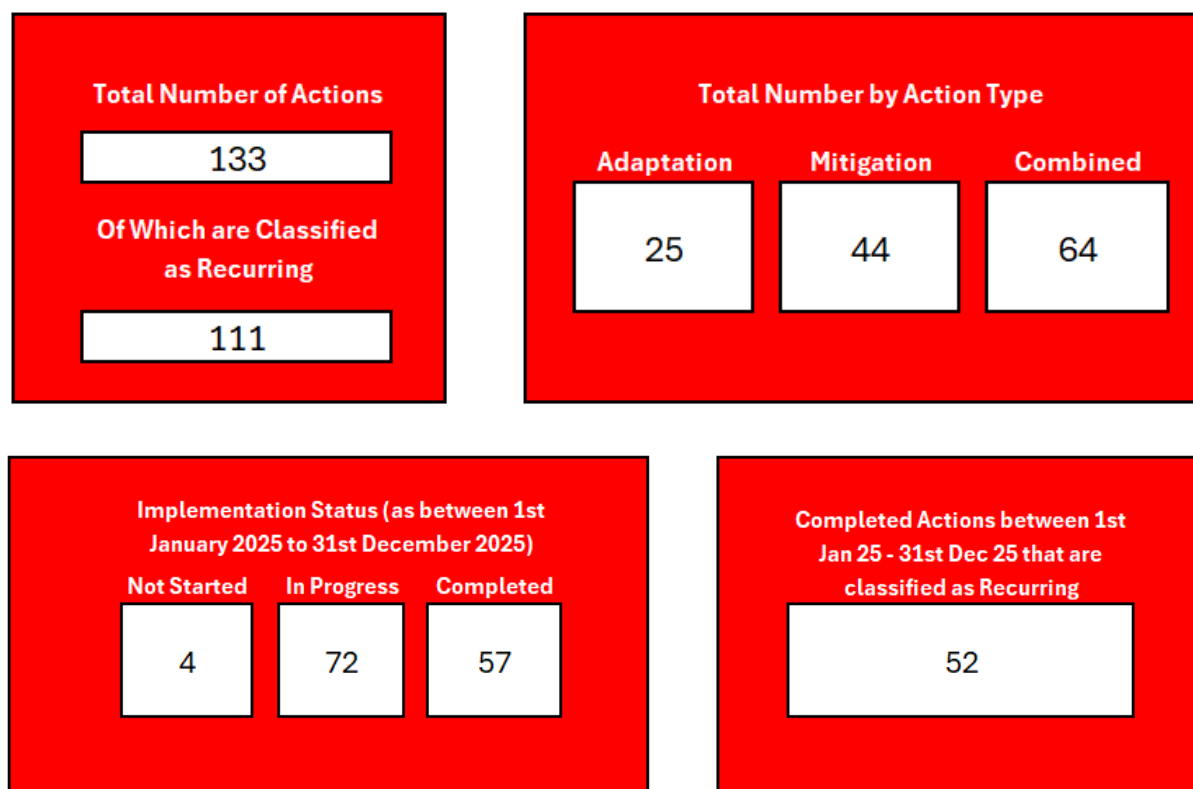


Figure 1: Climate Action Data Overview submitted to the CCMA ECCE Committee

The Climate Action Team (CAT) compiled the Climate Action Data Overview and submitted to the CCMA ECCE Committee. The results are as per Figure 1 for Wexford County Council.

The status of all 133 climate actions within Wexford County Council's Climate Action Plan is detailed in Figure 1 below.

Note: A recurring action is an action that will be implemented on more than one occasion during the lifetime of the plan. This could be that the action is to be implemented every year or on multiple occasions during this plan's timeframe.

Climate Action Tracker Report

The Climate Action Plan contains 133 actions (including DZ actions) across 5 Action Areas (see Figure 2 below). 95 of these actions relate to the entire County with 38 actions specific to the Enniscorthy Decarbonisation Zone (DZ). A sample of actions from each of the action areas will be outlined in this report.

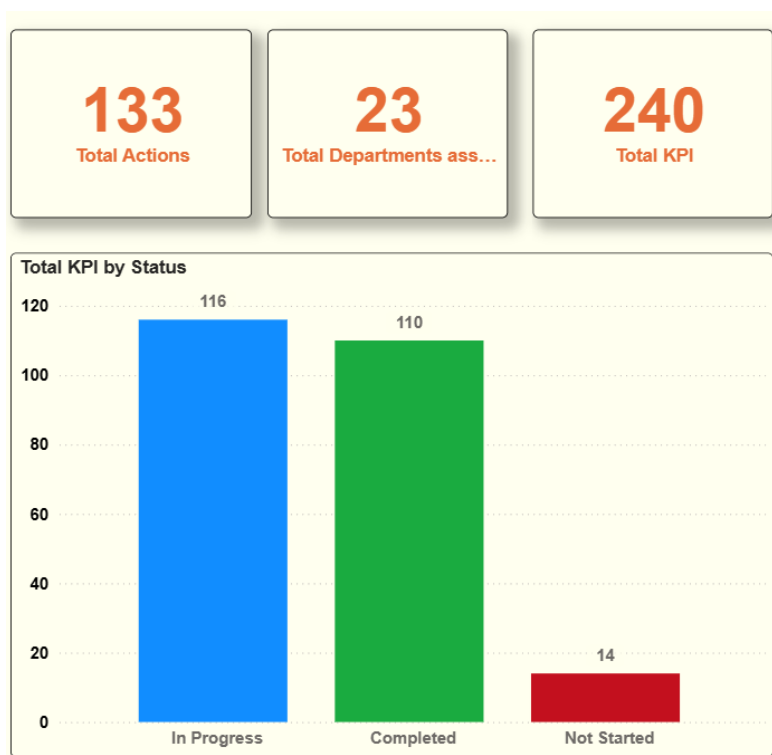


Figure 3: Wexford County Council status of Key Performance Indicators (KPI)

The statistics from the Climate Action Tracker report below are comprised of the status of all 240 Key Performance Indicators (KPIs) that relate to the 133 climate actions across. Some of the actions have numerous KPIs associated with them across 23 sections and operational areas (See Figure 3 below).

Monitoring and Reporting (SEAI M&R 2030 System)

Wexford County Council are legally mandated under SI 426 of 2014 to report our organisational energy and carbon emissions data through SEAI's online M&R 2030 platform. The M&R return requires Wexford County Council to report metered and unmetered energy consumption data from our owned/leased buildings, vehicle fleet and public lighting. The system also requires a working project list of energy conservation projects to meet our national 2030 public sector targets. Since 2024 the SEAI require additional data from public sector organisations Business Travel, vehicle fleet and a live building register.

Energy Elephant

Wexford County Council (WCC) collates, measures, and evaluates energy performance using Energy Elephant a third-party monitoring and targeting software application. Energy Elephant is Wexford County Council's central repository for our utilities meter and consumption point portfolio, cost and consumption data.

This software allows WCC to report, track, target and identify saving opportunities for all SEUs (significant energy users) and smaller usage points across the organisation for Buildings, Public Lighting, vehicles and other assets.

WCC's Energy Management System - EnMS ISO 50001:2018

Wexford County Council maintain a certified Energy Management System (EnMS) to the international management standard I.S. EN ISO 50001:2018.

This demonstrates Wexford County Council's commitment to manage, conserve and decarbonise our use of energy across the organisation.

In 2021, Wexford County Council was NSAI Certified to I.S. EN ISO 50001 - Figure 4 below refers. A recertification audit was carried out in May 2024 with a successful surveillance audit completed in September 2025.

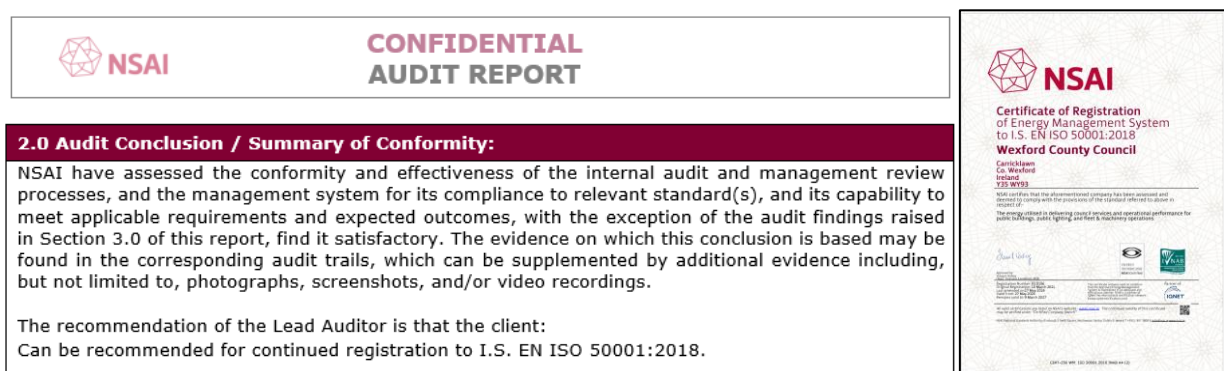


Figure 2: WCC's NSAI Certified ISO50001 EnMS

Progress of Actions

A suite of sample actions across various themes and Action Areas has been selected including relevant case studies and are outlined below.

Energy

Wexford County Council is obligated to achieve a 51% reduction in GHG carbon emissions (based on a 2016-2018 baseline) and a 50% improvement in energy efficiency (based on a 2009 baseline) by 2030 under the Climate Action Plan 2023 set out by the government.

*The Energy Efficiency Target normalises WCC's Annual Energy Consumption against Activity Metrics: Population Served, Number of Public Lights, Total FTE employees and Building Total Useful Floor Area. These Activity Metrics are allocated weightings (%) which combined form a "Composite Activity Metric" used to normalise WCC's energy consumption.

Wexford County Council (WCC) 2024 Energy and Carbon Emissions Performance

The following three targets must all be independently achieved by 2030.

- **Fossil Fuel CO₂ Emissions (Transport & Thermal):** Wexford County Council has reduced fossil CO₂ emissions by only 0.5% since our baseline (2016-2018 average). The fossil fuel emissions is 3,003 tCO₂ for 2024. WCC's current fossil CO₂ emissions target is 1,478 tCO₂ for 2030. This is not on a trajectory to meet the 2030 fossil CO₂ emissions target. Urgent Action is required.
- **Total CO₂ Emissions (Transport, Thermal & Electricity):** Wexford County Council has reduced total CO₂ emissions by 35.4% since the baseline (2016-2018) and is on a trajectory towards the 2030 total CO₂ target. The total emissions is 4,923 tCO₂ in 2024. The 2030 target is 2,464 tCO₂. This is on a trajectory to meet the 2030 Total CO₂ emissions target.
- **Energy Efficiency:** Wexford County Council energy performance has improved by 40.7% since the baseline and is on a trajectory that is consistent with meeting the 2030 energy efficiency target. Wexford County Council must improve energy efficiency by 9.3% by 2030. This is on a trajectory to meet the 2030 Energy Efficiency target.

The projected outlook for 2025 is a similar performance level to 2024. The final SEAI M&R Scorecard for 2025 is not available until August 2026.

2025 and 2026 were denoted as design years for the SEAI Pathfinder Retrofit Programme with works commencing from late 2026 onwards.

Bridging the gap – WCC Energy Action Plan

If WCC's list of planned energy projects, fleet decarbonisation, the forecasted decarbonisation to Ireland's electricity grid system and the biofuel blending strategy (as of 2024) are implemented between 2024 & 2030 our Fossil CO₂ emissions, Total CO₂ emissions and Energy Efficiency Targets can be achieved.

Further ongoing energy conservation measures include:

- Continual efficiency improvements via WCC's ISO 50001 Energy Management System
- Continual Electrification of our vehicle fleet
- Continual improvement of our vehicle fleet efficiency including Eco Driver Training
- Ongoing energy conservation communication and awareness training for all WCC staff

Important Note: Wexford County Council took over operational management of the Waterfront Pool & Leisure Centre in Enniscorthy in March 2024 to ensure the complex continues to serve the people of Enniscorthy and the District, into the future. The addition of this additional Significant Energy User (SEU) will impact Wexford County Council's gap to target reporting, as the addition of the Waterfront Pool & Leisure Centre will add a further circa 200 tonnes of CO2 per annum to our 2030 gap to target from 2024 onwards.

SEAI Pathfinder Retrofit Programme

Wexford County Council is fully committed to the SEAI Pathfinder Retrofit Programme. The Programme will provide Wexford County Council with 50% grant funding aid to assist with the decarbonisation and energy conservation of our seven highest Significant Energy User (SEU) buildings (see Table D).

The WCC SEAI Pathfinder Retrofit Programme targets a 500 tCO2 reduction in absolute carbon emissions by year end 2030.

Tipperary County Council, acting as Lead Authority for the Southeast Region (including County Councils of Carlow, Kilkenny, Tipperary Wexford and Waterford City & County Council) for the SEAI 2025-2028 Pathfinder Retrofit Programme. The Pathfinder

Programme Funding Agreement and Service Level Agreement was signed in January 2025 by Wexford County Council.

- €37.8 million has now been allocated to the Southeast Region in respect of the Pathfinder Programme 2025-2028
- WCC's estimated high level Budget for 2025-2028 Pathfinder Projects is currently €8.9m, of which 50% will be grant funded by SEAI

During 2025, a Multi-Party Framework for Design Consultancy Services has been procured with contracts signed (in December 2025) for the WCC initial Pathfinder Retrofit Programme Project : The Apex Leisure Centre New Ross.

Action GL1 falls under the Governance and Leadership Action Area and focuses on climate action resources within Wexford County Council and how they can be utilised to raise awareness on climate actions. It aims to foster ownership of actions in every service we provide as a Local Authority and through the incorporation of climate actions across all our functions.

Governance and leadership actions in County Wexford also support the following United Nations Sustainable Development Goals:



Transport

This area is focused on our efforts to reduce greenhouse gas emissions by 51% and energy consumption by 50% by 2030 in Transport. A number of measures have been undertaken to date and will continue to reduce Wexford County Councils emissions across our transport and fleet.

The measures and actions which align with BET 3 include:

There are 13 EVs as part of the Wexford County Council Fleet. Work is currently underway to create an onboarding video & Frequently Asked Questions for staff on EV driving to promote an increase in the use/uptake of electric vehicles with staff from the various sections.

The machinery yard is trialling the use of HVO in two heavy goods vehicles (HGVs) and three light goods vehicles (LGVs) since Feb 2025. It is planned to increase the number of vehicles on HVO. Cost savings on ordering HVO are available when ordered in bulk.

The pilot identified a slight increase in fuel usage from diesel fuel for all trial vehicles. It ranged from 10% increase in LGVs trialled and an increase of 15% fuel usage in the HGVs piloted.

FTA Ireland delivered ECO driver training sessions to fleet drivers in Wexford County Council in December 2025. The program consisted of a two-hour classroom-based theory session, followed by individual on-road practical training. In total, 20 one-to-one practical sessions were delivered, ensuring each participant received tailored instruction and feedback. The course was delivered in full compliance with the Department of Transport Eco-Driver Training Program requirement.

The average fuel saving for the training carried out over distances between 32 and 60 km was 1.03 litres of fuel and 2.5L/100km.

Implementing Eco-driving techniques can deliver substantial benefits for Wexford County Council:

- Fuel savings: ~1,120 litres per vehicle annually*
- Cost savings: ~€1,792 per vehicle annually*
- CO₂ reduction: ~3 tonnes per vehicle annually*

These figures highlight the significant financial and environmental impact achievable through consistent application of Eco-driving practices and enhanced through monitoring, supervision, and incentives.

*These figures are Estimated and are based on cost of diesel prior to the recent increases in fuel prices due to the middle east conflict. Financial savings would be significantly higher now

35 inefficient vehicles were removed from the fleet in 2024/2025. Many of these vehicles were not in mainstream use.

The transport area focuses on the promotion of alternative modes of travel to the private car vehicle use such as active travel and increased use of public transport. It also focuses on innovative ways of reducing emissions within the Wexford County Council fleet and an increase in the use of EVs and EV charging Infrastructure.

These measures align with action BET3, which falls under the Built Environment and Transport Action Area and supports the following SDGs:

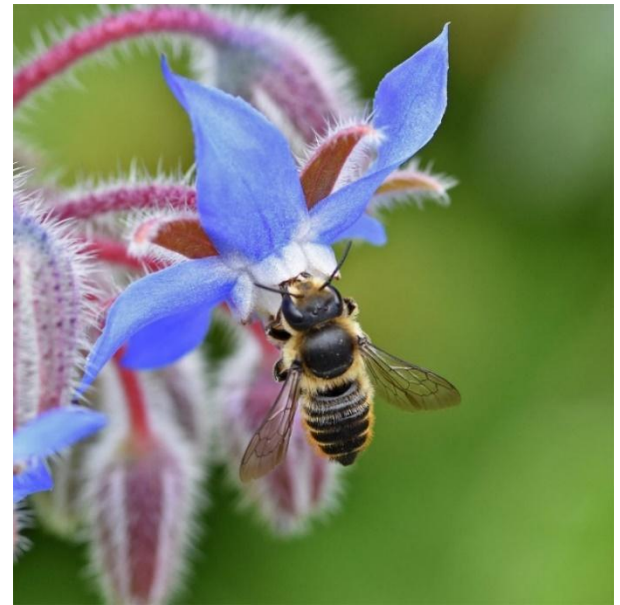

The Wexford Local Biodiversity Action Plan (LBAP) 2026-2031 sets out a vision for protecting the natural heritage of County Wexford.

The Plan proposes a structured approach to biodiversity conservation and restoration at a local level and closely aligns with the objectives of Ireland's 4th National Biodiversity Action Plan (Government of Ireland, 2024). Wexford faces challenges common across Ireland and Europe, including addressing habitat degradation and reversing the decline of species. The county's continued prosperity is dependent upon its capacity to achieve these objectives, thereby ensuring a healthy and resilient natural environment for generations to come.

The draft plan will go to public consultation in the 2nd quarter of 2026. The actions have also been the subject of Screening for Appropriate Assessment (AA) and Strategic Environmental Assessment (SEA). Stage 2 Strategic Environmental Assessment and Stage 2 Appropriate Assessment are not required.

Community Action

Wexford County Council in association with the Department of the Climate, Environment and Energy, has recently rolled out Phase 2 of the Community Climate Action Programme (CCAP). Funding is available for not-for-profit community groups and clubs for up to 100% of the cost of a climate action project.



Under Phase one of the Programme Co. Wexford was allocated €669,000 for community-based Climate projects. Following an extensive promotion campaign and a competitive assessment process, 16 groups were awarded funding out of a total of 52 applications.

Phase 2 of the Programme was open for applications for an 8 week period up to 16th December 2025. The county was allocated the same amount of funding again for projects. In total, 36 applications were received totalling €1.4 million in funding. The applications are currently being assessment with the successful projects due to be notified in April 2026 following a review by the DCEE.

The Climate Action team hosted its 2nd Climate Action Week/Fortnight from 12th – 25th May 2025. With the recent recruitment of a Biodiversity Officer, the theme for the fortnight was broadened to include Climate Action and Biodiversity. A number of events on the themes of Energy, Water Quality, Biodiversity, Active Travel, Circular Economy and Agriculture were held in the various municipal districts around the county. The fortnight was about raising awareness across County Wexford and served as a platform to inspire action and drive positive change at local level.

Talk on the Tides

Local community groups, Wexford County Council's Climate & team and Culture team and artists, came together to explore rising sea levels, sustainability, and the circular economy in ways that feel real, relevant, and rooted in local life. In August 2025, as part of House on the Beach, artist Nina McGowan unveiled her exhibition, Container, at Wexford County Hall, which explores our relationship to climate change and hosted a series of "Talk on the Tides" at coastal locations to share details of the project and invite feedback, and spark conversations around climate change and importantly, climate action.

Waste Segregation & Minimisation at the Fleadh Cheoil

Waste segregation units for four waste streams was provided - recycling, food, general waste and a separate waste bin for used vapes. The sustainability policy for traders was updated from 2024. The policy included no single use plastic and compostable only to standard EN 13432. The policy also included information on correct waste segregation with links to various resources & information. In 2024, Lantern Events launched an ambitious environmental initiative at the Breakwater festival during the

Fleadh Cheoil aimed at significantly reducing single-use plastic resulting in the avoidance of 47,500 plastic drinking cups.

Four drinking water refill stations in addition to the existing two stations were installed to reduce single use plastics and these stations are now permanent installations.

Sustainable Transport at the Fleadh

Ten Park & Ride car parks were in operation during the Fleadh festival with a minimum of five open at any one time with one additional location as back up. Buses were operating every 15 minutes. In 2024 over 23,000 cars used the Park & Ride facilities thus reducing this volume of traffic and emissions from the centre of town. In 2025, there was an increase of 30% to over 30,000 users of the Park & Ride facility. Local Link buses also operated from several rural locations.

The Bolt e-bike and e-scooter scheme experienced exceptional demand across the entire duration of the Fleadh. Demand was far higher than in 2024. The following gives an overview of the use during the 10 days of the Fleadh which saw visitor numbers at 800, 000 for the event.

The overall library book stock budget increased from €380,000 in 2024 to €390,000 in 2025, representing an increase of €10,000 year on year.

A dedicated allocation of €2,000 per annum was ring-fenced in 2024 and again in 2025 specifically for the purchase of climate action, sustainability and environmental stock, supporting Climate Action Plan objectives and the development of themed collections across the branch network.

In addition, supplementary funding was received under the Skills for Life programme, which was also applied to the acquisition of sustainability, climate literacy and low-waste living resources, further strengthening the Library Service’s climate-related collections.

In 2025, the library continued Circular Sharing of Information & Resources through various Digital Platforms including Borrowbox, Kanopy & Universal Clas. These resources provide online access to over 34,000 Wexford Library members.

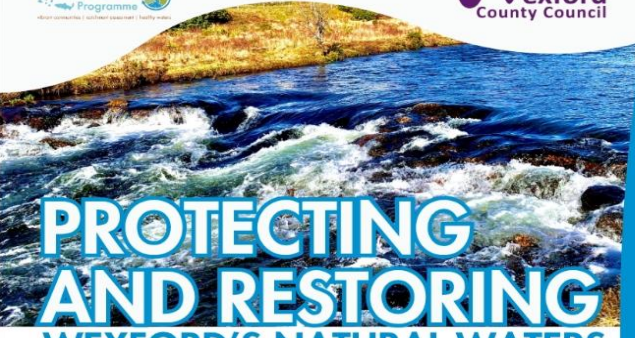

Business Energy Meitheal Event in Enniscorthy on 26th February 2025

A Climate Champions climate action competition was hosted by Wexford County Council's Climate Action Team in March 2025 for Businesses, Schools and Community Groups in Enniscorthy to improve climate action and sustainability awareness among these categories. Prizes were presented to the winners of each category at an event in May 2025 including the Business Category.



Winners of the Business Category Enniscorthy Climate Champions

The collective effort from the 3 categories made a significant environment impact:

- 10.669 tonnes of CO₂eq saved
- 14,324 activities logged
- 127kg CO₂eq average savings per participant

These numbers reflect real, measurable climate action — achieved through everyday behaviours, repeated consistently across dozens of teams.
